Before Care * (6:30 am - 7:45 am)	\$12
After Care * (3:15 pm - 6:30 pm)	\$20
Before & After Care	\$32

Special Days	
Half Day: After Care 12-3:30 pm	\$20
Half Day: After Care 12-6:30 pm	\$40
Half Day: Before & After Care until 3 pm	\$32
Half Day: Before & After Care until 6:30 pm	\$52

****Note: You will be charged the full Before or After Care daily fee if your child is present for any or all of the above established times.***

Late Pick Up per Student: \$1 / min after 6:30 with \$15 minimum

Billing: Billing will be monthly and charged to your FACTS account. Payment is due on or before the 11th of each month. If payment is after the 11th there will be an additional \$25 late fee charge. *You are only charged for the days your child is present in Before or After Care.*

Before Care 6:30 am - 7:45 am

- Students may eat breakfast brought from home.
- Time will be provided for homework and study.
- Quiet games and puzzles will be available.

After Care 3:15 pm - 6:30 pm

- 3:15-3:30 Snack time (snack provided by the students)
- 3:30-4:15 Homework and Study
- 4:15-5:00 Play outside (weather permitting) or in the gym
- 5:00-6:30 Computer, arts and crafts, homework, games, and movies on rotation

Special Closings/Opening:

- There will be After Care on GCS scheduled half days until 6:30 pm, with the exception of the last day of school.
- Before Care will be available on two-hour delayed-opening days beginning at 8:30 am.
- After care will *NOT* be available on days with early dismissals.
- Before or After Care will *NOT* be available when school is closed due to weather.

Daily Snacks:

- Your student will have a snack time in After Care. Please provide a healthy snack of fruit, crackers, juice, etc. Please do not send candies or sodas.
- Food sharing is not allowed. We have students with peanut and other food allergies.
- Please label ALL your student's belongings. Anything left behind will be put in the school's lost and found.

Students planning to be involved in sports or any other after school program MUST be registered in the After Care program. When sports practices, games or other after school activities are canceled and your student must remain at school until picked up, the Office of Child Care laws mandate that all students must be registered and have their information on file to stay in After Care.

After Care is the **ONLY** available arrangement for students not picked up on time. Students are not allowed to be unsupervised in any other part of the building after dismissal. Be aware that if your student is not registered in the After Care Program, you will be charged the **double rate** of the standard daily After Care fee when your child is picked up late.
