## **TUITION:**

Grace Christian School has a two-tiered tuition schedule. The charts below show a breakdown of the payment for elementary and middle school students. Parents desiring to pay tuition in full (due August 15) or in two equal installments (due August 15 and January 20) may make these payments directly to the school or through your FACTS account.

For all other payment options (monthly, quarterly) a FACTS Agreement must be established for direct debits from a bank account or credit card.

An August payment is MANDATORY if student(s) entry/acceptance date is by August 31. All payments are subject to late fees if not paid by due date and service fees if your bank rejects payment.

FACTS Agreements for returning families are renewed with the new tuition rates per student. Agreements will be activated by April 30 for those students whose re-enrollment fee has been paid.

Re-enrollment for returning students begins February 1, 2023 (Class space is reserved when the enrollment fee is paid in full). Beginning March 1, 2023, enrollment will be open to new families.

APPLICATION/TESTING FEE (per new incoming student) - \$150 (payment made online)
ENROLLMENT/RE-ENROLLMENT FEE (per student each year) - \$535 (payment via Family Portal online)

## **ADDITIONAL SCHOOL FEES:**

SPORTS: - Fall and Spring Sports - \$80 per student, per sport; Winter Sports - \$100 per student, per sport;

Development Team - \$50 per student, per sport.

TRANSACTION FEES: \$25 each occurrence for late payments past due date or returned payments for any reason.

BEFORE/AFTERCARE as designated in BAC instructions and policy (payments are offered online via Family Portal, by check or cash paid to the school office)

LATE PICKUP - Charges assessed per Student/Parent Handbook when student is not registered in BAC program.
